Location

The unit is situated with prominent frontage to Sloper Road close to its junction with Penarth Road. Penarth Road is a major arterial route linking Cardiff City Centre with the A4232 which provides easy access to Junction 33 of the M4 and access to the Cardiff Bay area some 2 miles to the south.

Penarth Road is a buoyant and much sought after location and is home to a wide variety of users. Retail warehouse occupiers in the location include Baileys, Dreams, many of the major car dealerships – Honda, Land Rover, Renault, MG and BMW – and numerous trade counter and cash and carry operators.

Description

The property is a purpose-built unit with steel portal frames and a concrete mezzanine floor covering almost half of the unit (available on request). The front of the premises is fully glazed with pedestrian access. Customer car parking is provided at the front and can accommodate upwards of 13 spaces. The unit also benefits from W/C and kitchen facilities to the rear.

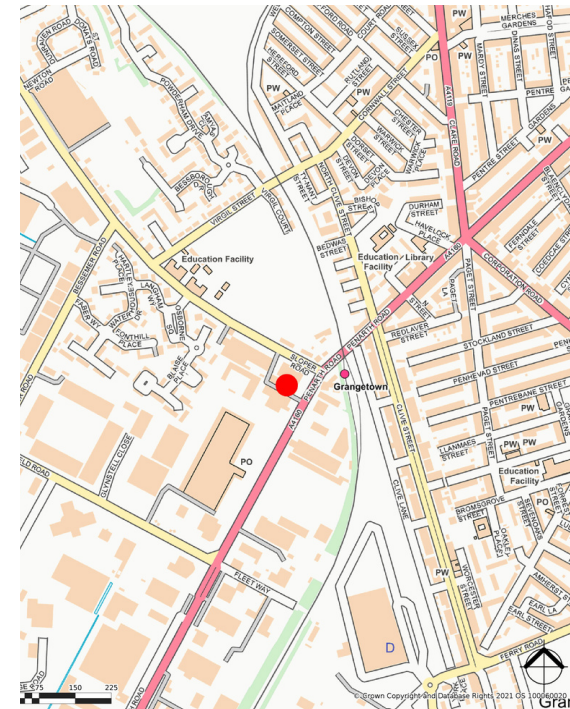
