Location

Melyn Mair Business Centre is located on Lamby Way Industrial Estate to the south of Wentloog Avenue, Rumney. It is approximately 3 miles to the north-east of Cardiff City Centre and within 1 mile of Southern Way (A4161) which leads directly onto the A48 Cardiff to Newport trunk road and Junction 30 of the M4 motorway.

Description

The subject unit is in a mid-terrace of six similar industrial/office units. Part of the ground floor and first floor provide high specification office space. The remainder of the ground floor is warehouse storage accessible by two roller shutter doors.
