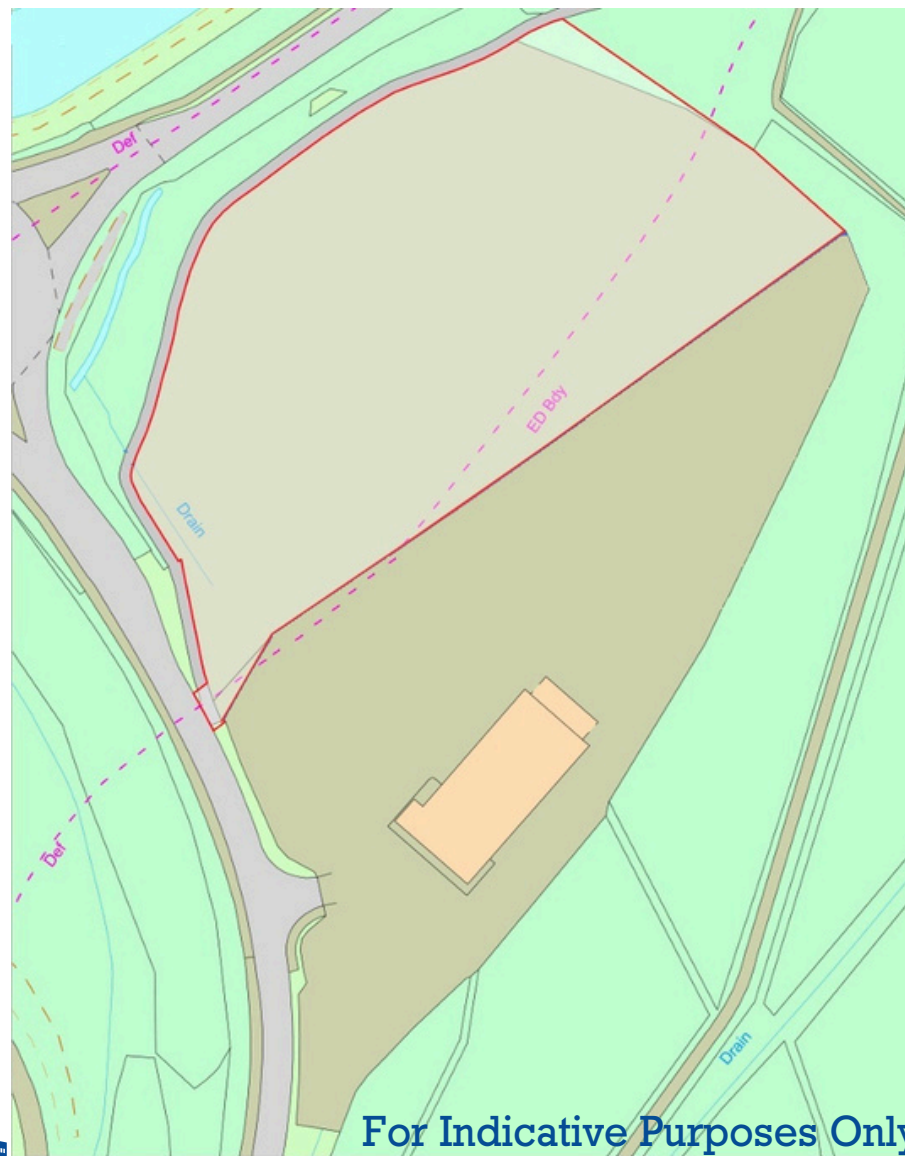

Location

Tredegar is situated just south of the A465 Heads of the Valleys Road in Blaenau Gwent. The town has an approximate population of 15,100 (2011 Census) and is a well established industrial location, with a number of large industrial estates. The proposed south Wales Metro system will include a station at Tredegar.

The property is located on Crown Business Park, located immediately south of the A465 Heads of the Valleys Road. Following the upgrading of this road, it now provides excellent access to Merthyr and the A470 to the east. To the west access is provided to Abergavenny, the A40 and the Midlands (via the M50 motorway).

Crown Business Park is home to a range of industrial, logistic and trade counter style operators including **David Spear Commercial, Amazon, G-TEKT, Purflux, Fleetwheel** and many others.

Description

The proposed development site has a self-contained double gated access onto the main estate road into Crown Business Park, and is secured by palisade fencing.

The site has the potential for a variety of uses such as trade park, retail warehouse, self-storage, industrial or last mile logistics – subject to planning.

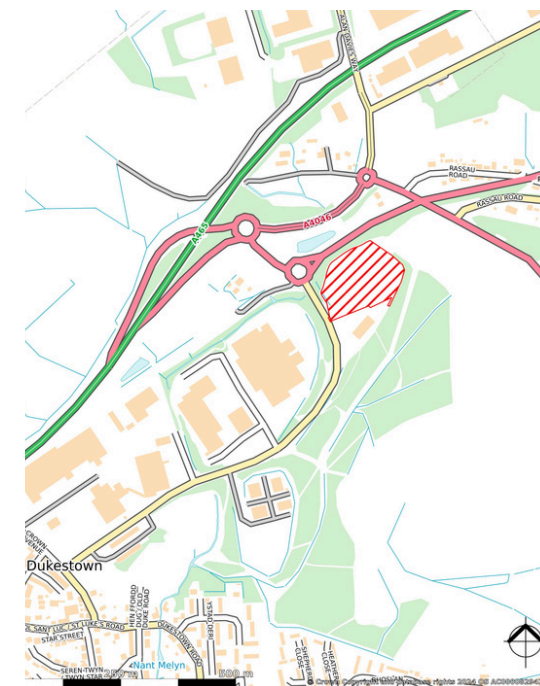
