## Location

The unit is based on Central Park within Bridgend Industrial Estate, a modern warehouse development and one of South Wales' most established commercial and industrial locations. There are several local and national occupiers within the area including **PCI, Edmunson Electrical, MKM and Evri**.

The unit is located to the north of the main estate road, Western Avenue, a principal arterial route through the estate, and benefits from immediate access to the A473 dual carriageway, which links directly to Junction 35 of the M4 Motorway, approximately 2 miles to the east.

This location provides good connectivity to Cardiff, Swansea, and the wider South Wales M4 corridor.

## Description

An end of terrace unit of steel portal frame with a pitched roof. Briefly, the property comprises:

1. Ground floor warehouse
2. Kitchenette and WC facilities
3. 3 phase power
4. Level access roller shutter door (4 x 5.75m)
5. 5 dedicated car parking spaces
6. Minimum Eaves 6.9m

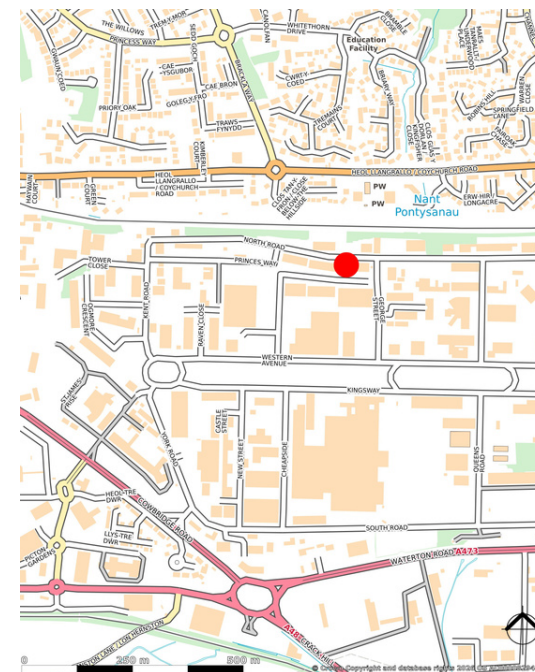
